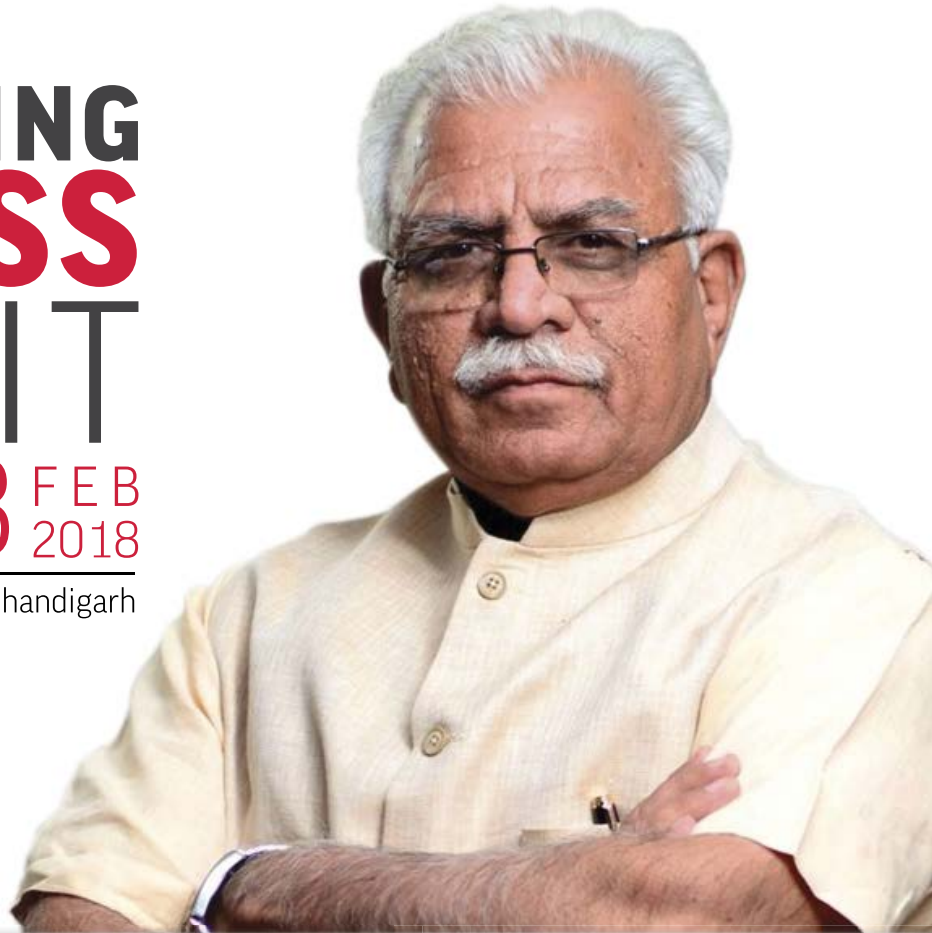

Ease of Doing Business: Key reforms

1. **Single Window System** : Single window clearance constituted and housed within CMO whereby all clearances shall be granted within 2 months. It is a system to facilitate online clearances which has been put in place by creating an e-biz Haryana portal (www.investharyana.gov.in) where composite application forms can be submitted by an investor for 64 services for securing online clearances/ sanctions/ permits/NOCs.

2. **Sole Point of Contact** : The state has established a dedicated physical body/ bureau that functions as the sole point of contact for the purpose of setting up a business through the Haryana Enterprise Promotion Act 2016.

3. **Online System for Consent to Operate**: The procedure and list of documents for obtaining CTO under The Water Act 1974 and The Air Act 1981 is present online. Consent to operate is granted for period of 5 to 10 years.

4. **Online Investment Wizard**: Investment Wizard was developed by INVEST HARYANA Portal to inform investors about the regulatory clearances needed for their projects. The facility is available under Know Your Clearance section.
